Final notice to 117 candidates who do not fulfill the qualifications and to 18 absent candidates for the post of Nursery Teachers (NTT) against Advertisement NO. 04/2023.

Education Department, Chandigarh Administration had invited online applications from eligible candidates to fill up 100 posts of Nursery Teachers (NTT) on regular basis for which advertisement was published / uploaded on 28.12.2023. Written Test for the said posts was held on 07.04.2024. Provisional Merit list prepared on the basis of marks in the written test has also been uploaded on the website.


As per details mentioned in the advertisement, candidates 1.5 time (one and half time) the number of posts under each category were called for scrutiny of original documents under each category on 04.07.2024. Another chance was given on dated 01.08.2024.

After checking of original documents, it has been observed that 117 candidates do not fulfill the qualifications for the post of Nursery Teachers (NTT). List of the said candidates has been uploaded on the website <https://www.chdeducation.gov.in>. However before declaring these 117 candidates ineligible, they are given final opportunity to prove their eligibility on 23.08.2024 at 12:00 Noon at GGMSSS, Sector-18, UT, Chandigarh before core committee. It is clarified that no further opportunity will be given.

Further, 18 candidates did not appear before the documents checking committee on 04.07.2024 and 01.08.2024. List of said 18 absent candidates has also been uploaded on the website. These absent candidates are hereby given final opportunity to get the documents checked on 23.08.2024 at 12:00 Noon at GGMSSS, Sector 18, UT, Chandigarh. It is clarified that if they do not attend to the documents verification as above mentioned, no further opportunity will be given and their name will be deleted from the provisional merit list for the post of Nursery Teachers (NTT).

Further, 03 candidates (as per list) have not submitted requisite documents and their candidature is still under consideration. These candidates are also advised to submit the requisite documents on 23.08.2024. No further opportunity will be given.
