NOTIFICATION

New Delhi, the ___ April, 2023

G.S.R. ___, In exercise of the powers conferred by the proviso to article 309 of the Constitution and Govt. of India Gazette notification No. G.S.R 230 (E) dated 29.03.2022, and in supersession of the Chandigarh Educational Service (Group 'A' Gazetted) **Government Arts and Science Colleges Rules, 2010**, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of **Principal (Group 'A' Gazetted post), Government Arts & Science Colleges, UT Chandigarh** namely:-

1. **Short title and commencement.** - (a) These rules may be called the Government Arts and Science Colleges, UT Chandigarh (Principal Group 'A' Gazetted post), Recruitment Rules, 2023.
(b) They shall come into force on the date of their publication in the Official Gazette.
2. **Application.** -These rules shall apply to the posts specified at serial no. 1 of the Schedule annexed to these rules.
3. **Number of posts, classification and Level in pay matrix.** - The number of posts, its classification and level in pay matrix attached thereto shall be as specified from serial no. (2) to serial no. (4) of the Schedule annexed to these rules.
4. **Method of recruitment, age limit, other qualifications etc.** - The method of recruitment, age limit, qualifications and other matters relating to the said post shall be as specified from serial no. (5) to serial no. (13) of the said Schedule.
5. **Disqualification.** -No person, -
 - (a) who has entered into or contracted a marriage with a person having a spouse living, or
 - (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:
Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.
6. **Power to relax.** - Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.
7. **Saving.** - Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

If a Grade point system is adopted, the CGPA will be converted to equivalent marks as below:</p> <p>Grade Point equivalent percentage of marks</p> <p>6.25 –55%</p> <p>6.75 -60%</p> <p>7.25- 65%</p> <p>7.75-70%</p> <p>8.25 -75%</p> <p>Note-2: The period of deputation (including Short-term contract) including period of deputation (including Short-Term Contract) in another ex-cadre post held immediately, preceding this appointment in the same or some other organisation or Department of the Central Government shall be for a period of five years, extendable for another term of five years on the basis of performance assessment by a Committee constituted as per UGC Regulations, 2018. After the completion of his/her term, the incumbent shall join back his/her parent organization with the designation as Professor and in the grade of the Professor. The maximum age limit for appointment by deputation shall not exceed fifty-eight years as on the closing date of receipt of applications.</p>
