Sealed quotations are invited from interested vendors/parties for the disposal of approximately **1148 empty oil tins** lying in the MDM Store, Plot No. 23-A, Industrial Area, Phase-I, Chandigarh under the PM POSHAN Scheme, Chandigarh Administration.

The quotations shall be received in the office of the District Education Officer, U.T. Chandigarh up to **08-07-2026 at 11:00 AM** and will be **opened on the same day at 03:00 PM** in the presence of the committee members and the bidders who may wish to be present.

Terms & Conditions: -

1. Interested parties may inspect the material at MDM Store, Plot No. 23-A, Industrial Area, Phase-I, Chandigarh on any working day during office hours before submission of quotations.
2. The quotation must clearly indicate the rate per tin, inclusive of all charges.
3. The sealed quotation duly signed should reach the office of the undersigned on or before **08-07-2026 up to 11:00 AM**.
4. The disposal shall be made in favour of the highest bidder, subject to approval of the competent authority.
5. The successful bidder shall be required to deposit **25% of the bid amount as Security Deposit/Initial Deposit** within the stipulated period of 10 days from the date of intimation of selection of highest bidder. The material shall be lifted on as is where is basis within period of 30 days from date of intimation of his/her selection as highest bidder. 100% quoted amount inclusive of taxes shall be deposited before lifting the material. The security deposited shall be adjusted in the final payment.
6. The successful bidder shall deposit the full amount within the stipulated period and lift the material from the MDM Store at their own cost and risk.
7. Amount shall be received by Demand Draft or Cheque in favour District Education Officer, U.T., Chandigarh.
8. The department reserves the right to accept or reject any or all quotations without assigning any reason.
