Education Department, Chandigarh Administration framed the Rules called "the Chandigarh Educational Service (School Cadre) Group C Rules, 1991. In the said notification, Rules were framed for the post of Lecturers, Headmasters, Masters/Mistress, JBT and NTT teachers etc.

On the basis of the recommendation of Internal Departmental Committee, recruitment rules notified by the Govt. of Punjab vide notification dated 21.05.2018, NCTE notification issued in the year 2014 related to minimum qualification and the teaching subjects offered by various universities, it has been proposed to amend qualifications for TGT Social Studies and TGT Sanskrit as under:-
